RABA Finances:

- 1. The Treasurer's report (attached) was approved unanimously.
- 2. Jim P review the expenses associated with Duplimating (attached). The following schedule of charges for duplimating was approved:
 - a. Use of Duplimator: \$1 per set of Boards
 - b. Labor for Duplimating: \$4 per set of Board
 - c. Printed Hand Records: 4 cents per sheet

Items from Jim Patton:

- 1) F2F bridge openings: Doug/TBK on Tu/W/F starting July 9, Mary Lou on F starting July 16, Temple Sinai not open, Bruce is not ready to open.
- 2) VC Games are continuing but 1.25X MP as of July 1.
- 3) RABA purchased a Brothers HL-L6200Dw printer for creating hand records.
- 4) The copier has been returned to the lease company. There was a \$500 restocking and transportation fee for ending the current lease agreement.
- 5) The Moose Club has been booked for all 2022 Sectional Tournaments.
- 6) Nominations are being sought for the RABA Board Sept. election. We need to finalize the ballot by mid-August. We are electing three people to the Board. Since Barbara McIver and Jane Romal are not continuing, two board members will be new. A key need is a treasurer. That person must be familiar with constructing a Profit and Loss Statement, using Excel, and balancing a checkbook. Board members should contact players who are strong candidates directly to urge them to run. Send names to the nominating committee (Romal, Sutter, LaTart).
- 7) The next RABA sectional is scheduled October 2-3, 2021 at the Webster Recreation Center. The rental cost will be \$450 per day. Consequently, it was agreed previously that the entry fee per session will be \$12. ACBL guidelines need be followed with respect to Covid-19 restrictions. As a result:

 - d. The ACBL requirements continue to evolve. Once we know more, can make final decisions about further covid precautions.
